In August 2021, Damar was selected to join the Trust Conference Changemakers Programme 2021 by the Thomson Reuters Foundation. In 2018, he was selected to join the International Visitor Leadership Program (IVLP) 2018: Cyber Policy and Online Freedom of Expression by the US Embassy. In the same year, he received the Netizen Award 2018 from Marketeers.com. Apart from being a speaker at international, regional and national forums, he also often writes opinions on new media, social media, digital policies and online freedom of expression.
