## Apar Gupta

Apar Gupta is a lawyer and writer on democracy and technology, and the founder-director of the Internet Freedom Foundation (IFF). He has acted as a counsel in leading constitutional cases on freedom of speech and privacy. Apar was the co-founder of SaveTheInternet.in, a grassroots campaign that mobilised over a million Indians and secured strong net neutrality safeguards, and since 2018, he has lead IFF, where he pairs campaigns with policy advocacy and impact litigation on issues of digital access and coercion. He has assisted in drafting three distinct private member's bills introduced in the Lok Sabha and has also deposed before Parliamentary Committees on Information Technology and on Science and Technology on topics of study including net neutrality, internet shutdowns, online obscenity and the DNA Bill. In recognition of this work, Apar was elected an Ashoka Fellow in 2019. Apar writes and speaks widely on law, technology and democratic governance and is globally cited as an expert by publications including *Wired*, *MIT Tech Review*, *Financial Times* and *The Guardian*.
