Nenden Sekar Arum is the executive director of the Southeast Asia Freedom of Expression Network (SAFEnet), where she leads efforts to promote digital rights, freedom of expression and online safety in Indonesia and Southeast Asia. With a background spanning journalism, data technology and human rights advocacy, she co-founded the Indonesian Data Journalism Network (IDJN) to strengthen transparency and accountability through data-driven reporting. Nenden also serves as secretary of the Indonesian Journalist Safety Committee (KKJ) and is an active member of KOMPAKS, a coalition combating sexual violence.

Damar Juniarto is a prominent figure in artificial intelligence, digital democracy and media integrity. He founded the Indonesia Working Groups against Digital Disinformation (KONDISI) in 2019 and the Center for Artificial Intelligence and Technology Innovation for Democracy (PIKAT) in 2024; both initiatives are aimed at enhancing democratic values within the digital space while combating digital disinformation in Indonesia. He also serves as a member of the Committee on Platform Responsibility for Quality Journalism (KTP2JB), as a board member of Amnesty International Indonesia, and as an external consultant to the United Nations Artificial Intelligence Advisory Body. In addition, he is a university lecturer teaching digital politics at Universitas Pembangunan Nasional "Veteran" Jakarta (UPNVJ) and a visiting fellow at Future Shift Labs, a think tank organisation based in Uttar Pradesh, India, starting from 2025. Previously he was the co-founder and leader of the Southeast Asia Freedom of Expression Network (SAFEnet) from 2013 to 2023.

Sanhawan Srisod is a senior legal adviser with the International Commission of Jurists (ICJ), based in Bangkok, Thailand, where she has served since 2016. She leads and implements the ICJ's global initiative to develop the Global Principles on Securing Human Rights in the Digital Space, jointly carried out with the Danish Institute for Human Rights, as well as projects in Thailand and across Southeast Asia. Her work focuses on legislative monitoring, legal research and advocacy on a broad range of human rights issues, including civil, political, economic, social and cultural rights, gender equality, business and human rights, and access to justice. She regularly coordinates the preparation of legal analyses, court submissions and reports, and facilitates judicial dialogues, trainings and regional workshops for justice sector actors and civil society partners. Before joining the ICJ, Sanhawan worked with the International Committee of the Red Cross (ICRC) in Thailand's southern border provinces. She also served with the Australia-Asia Programme to Combat Trafficking in Persons. Sanhawan holds an LL.M. in Public International Law from Leiden University and an M.A. in Criminology and Criminal Justice from Chulalongkorn University.

Jam Jacob is a recognised authority in data protection, having spent over 14 years working on data protection and 17 years practising law. An IAPP Fellow of Information Privacy and a Certified Implementer of both Privacy Information Management Systems (ISO 27701) and Information Security Management Systems (ISO 27001), he was the first policy head of the Philippines National Privacy Commission. There, he was instrumental in the development of the agency's initial issuances, including the implementing rules of the country's data privacy law.

Today, he is the data protection officer of the Ateneo de Manila University, and policy and legal advisor of the Foundation for Media Alternatives, a non-profit organisation advocating for human rights in digital spaces. He also heads the LIGHTS Institute, an advisory and research firm. A regular resource person at various forums and to news organisations, both domestic and foreign, Jam also occasionally contributes to news platforms and other publications.

He has degrees in Sociology and Law from the University of the Philippines, an LLM from the University of Auckland, and he has taken the Summer Course on US-EU Privacy Law and Policy at the University of Amsterdam.
